## **Wisconsin Forest Landowner Grant Program**

(WFLGP) funding is available for forest landowners owning more than 10 contiguous acres. WFLGP funding can only be cost-shared for non-commercial practices. A Forest Management Plan must be in place. Forest and savanna restoration practices can be covered by this program. Note: Also apply to have a forest management plan prepared through the WFLGP program. The next deadline for applications is November 1.

# **Conservation Practices on Working Lands**

# Farm Bill Programs

USDA - Farm Service Agency (FSA) and Natural Resources Conservation Service (NRCS) are two federal agencies that work with farmers to implement conservation practices through local offices and contacts.

FSA supports agricultural producers and other private landowners by offering a variety of farm loans, price supports, and disaster relief and conservation programs.

**Conservation Reserve Program (CRP)** is a land conservation program administered by FSA. In exchange for a yearly rental payment, farmers enrolled in the program agree to remove environmentally sensitive land from agricultural production and plant species that will improve environmental health and quality. Contracts for land enrolled in CRP are from 10 to 15 years in length. The long-term goal of the program is to re-establish valuable land cover to help improve water quality, prevent soil erosion, and reduce loss of wildlife habitat.

The General CRP Sign-up is open annually during announced enrollment periods. Offers for CRP contracts are ranked according to a system called the Environmental Benefits Index (EBI). Visit <a href="www.fsa.usda.gov">www.fsa.usda.gov</a> for details. The Continuous CRP Sign-up is open throughout most of the year, with a deadline normally in mid-September. The Continuous Sign-up allows environmentally sensitive land devoted to certain conservation practices to be enrolled at any time and is not subject to competitive bidding.

Examples of enrollment opportunities include:

**Monarch SAFE** aims to increase habitat for pollinators and Monarch Butterflies through creation and restoration of habitats that include targeted and secondary plant species.

**Southwest WI Grassland Area SAFE** goal is to restore and maintain grassland and prairie habitat for bird species of greatest conservation need in WI.

**Conservation Reserve Enhancement Program** agreements are designed to address water quality issues in specific geographic areas. Practices that can be utilized include riparian buffers, filter strips, and pollinator plantings.

#### How do I enroll?

For all program questions and inquiries, it is recommended to stop by or make an appointment with your local NRCS office and work with the staff to see what programs or assistance fits best for you and your land.

As part of the application process you will need to provide:
-an official tax ID (SSN or employer ID)
-A property deed or lease agreement to show control of the property AND
-A Farm and Tract number (if you don't have one, you can get one from FSA)



# **Conservation Practices on Working Lands**

# Farm Bill Programs

NRCS has a focus on working with landowners on private lands to conserve natural resources. NRCS provides farmers, ranchers, and woodland landowners with financial and technical assistance to voluntarily put conservation on the ground. Examples include reducing erosion, conserving and protection water, and restoring and creating wildlife habitat.

**Environmental Quality Incentives Program (EQIP)** is a program run by NRCS to provide financial and technical assistance to deliver environmental benefits such as improved water quality, increased soil health, reduced erosion, or improved and created wildlife habitat. This program offers private landowners the chance to voluntarily implement conservation practices and NRCS co-invests in these practices with you. If a project is funded, it results in a one-time payment to help implement your chosen practice. Examples of practices commonly used in WI include:

- Wildlife Habitat Planting
- Forest Stand Improvement
- Upland Wildlife Habitat Management
- Brush Management
- Prescribed Grazing
- Filter strips
- Field Borders

**Conservation Stewardship Program (CSP)** is a program run by NRCS to help agricultural producers and private landowners maintain and improve their existing conservation systems and then further adopt additional conservation activities to address priority resource concerns. This program is best suited for operations that are actively participating in conservation efforts but would like to expand them further. Financial assistance is provided to maintain those existing efforts and also to include additional activities.

# Enrollment period now open! Driftless Regional Conservation Partnership Program (RCPP)

The project provides Driftless Area landowners with conservation planning services and direct financial support for the following EQIP practices:

- Prescribed grazing, including pasture seeding, fencing, lanes, and water lines.
- Oak savanna restoration, including brush management, invasive species control, and prescribed burning.
- Agroforestry, including alley cropping and silvopasture.
- Prairie buffers and borders, both in-field and edge-of-field.

Contact your local NRCS office or your PF Farm Bill Biologist to learn more. Applications are invited on a continuous basis and are ranked and awarded one to two times per year.
